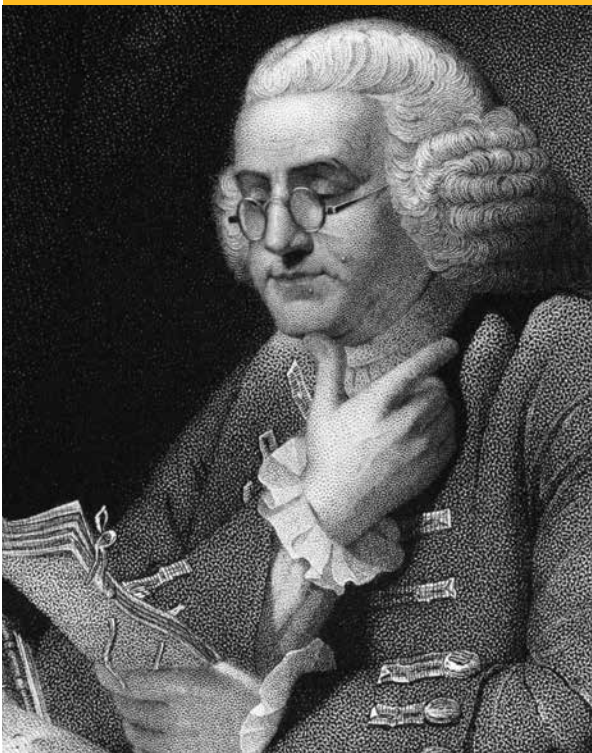

Executive Summary

The Greater Kanawha Valley Foundation has been making significant investments in post-secondary education since 1962. The generosity of our donors makes these investments possible.

This report summarizes the 2010 to 2015 period, capturing who received scholarships, the top institutions of choice, our annual investments, and stories of impact. Analysis revealed that the

number of women receiving scholarships was greater than the number of men. Caucasians received more scholarships than any other ethnic group. One-quarter of recipients have a household income between \$25,000 and \$49,999. More than one-quarter of recipients reside in Kanawha County. West Virginia University was the institution of choice for the largest fraction of scholarship recipients.

Brief Foundation History

The Greater Kanawha Valley Foundation (TGKVF) was created in 1962 by and for the people of the Greater Kanawha Valley area. This area encompasses the following six county region: Kanawha, Putnam, Boone, Clay, Lincoln, and Fayette. TGKVF is the largest community foundation in the State of West Virginia and in Central Appalachia.

The Foundation exists to help individuals, families, businesses, and nonprofits improve lives within the community now and for generations to come. We assist donors in creating charitable funds, each with its own philanthropic purpose, and provide grants to nonprofits that meet the needs of the community.

The mission of TGKVF is to make thoughtful and proactive investments that grow the multiple forms of wealth necessary for our community to thrive. These forms of wealth include the individual, intellectual, social, political, natural, built, and financial assets within our community.

The vision of TGKVF is a forward-thinking and closely connected community that fearlessly works together to promote the prosperity of all.

Scholarship Program Overview

The TGKVF Scholarship Program started in 1962 through the generosity of Greater Kanawha Valley residents and is available to all students in West Virginia. Online applications became available in 2008. The annual application period is from November 1 to January 15. A team of 80 volunteers, who serve on 12 scholarship committees, reviews applications and recommends recipients to the board by April. TGKVF scholarship awards are made in August and typically range between \$500 and \$10,000.

The Foundation also administers funds for various colleges/universities. Recipients of these scholarships are selected by the respective college/university.

We welcome donors who would like to add to existing scholarship funds or those who would like to invest at least \$20,000 to begin and name a new fund.

Receiving a scholarship from TGKVF and having the opportunity to renew it annually helped me with my ultimate goal of paying my way through college without taking out loans. After graduating with an Accounting degree from WVU this past May, I was able to move across the country to California, a place I've always been intrigued with. I would never have been able to embark on this adventure if I was locked down with student debt. Scholarships from donors like TGKVF were extremely helpful in assisting me with staying debt free. As of now, I plan on starting my career with Alliant Insurance Services as an Accounts Receivable Clerk. I am very excited to see where my determination and work ethic takes me.

Table 1 shows that the percentage of female scholarship recipients was approximately double the percentage of males for each year of the 2010–2015 period.



I received The Greater Kanawha Valley Foundation scholarship for the duration of my undergraduate degree at Davis & Elkins College and my Master’s degree at American University. This scholarship allowed me to finish both my degrees debt-free, something most students cannot accomplish in their lifetimes. While at Davis & Elkins College, I was able to participate in two winter terms—one for Marine Science in the Florida Keys, the other in Rainforest Ecology in Ecuador—that were only made possible due to this scholarship and my summer internships. This past January, I was able to go to Cuba as an alumna with D&E, which I was able to afford since all of my tuition at American University was covered by this scholarship and one from the Garden Club of America. I truly appreciate the Greater Kanawha Foundation for believing in my educational goals and helping me experience educational trips that I would otherwise not have gotten to participate in. After finishing my Master’s in Environmental Science through American University, I was able to secure a job in the greater DC area, Silver Spring, MD, working as a Water/Wastewater Quality Chemist at the Washington Suburban Sanitary Commission, which treats the water and wastewater of the two largest counties in Maryland. I am currently looking for a position more closely related to my field of study in Washington, DC, or in my home state of West Virginia. 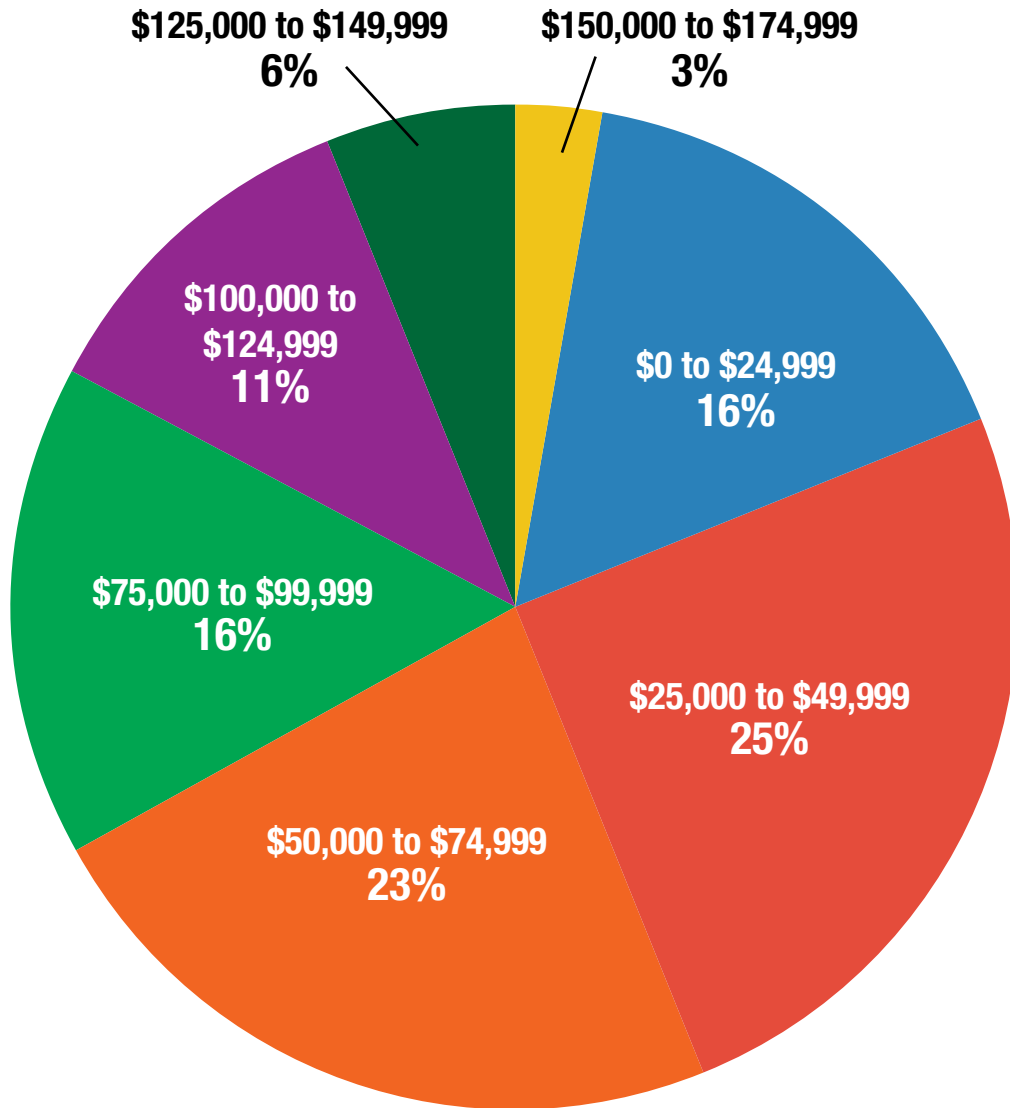

Table 2 shows that two thirds of scholarship recipients between 2010 and 2015 were Caucasian and 30 percent did not provide ethnicity information. It should be noted that the ethnicity field on the scholarship application will be mandatory starting in 2017. The percentage of Caucasian recipients increased during the period, while the percentage with missing information decreased during the period. The percentage of African American recipients fluctuated during the period and peaked in 2011 at 1.9 percent.



Figure 1. Household Income of Scholarship Recipients



One quarter of scholarship recipients between 2010 and 2015 were in the \$25,000 to \$49,999 household income bracket, as shown in Figure 1. The \$50,000 to \$74,999 bracket was a close second at 23 percent. Forty-one percent of recipients were from households with less than \$50,000.



Angie Settle, with the aid of a TGKVF scholarship, was able to begin an academic journey that would continue through undergraduate, master, and doctorate degrees. Angie's hard work and desire to serve her community have propelled her to reach her education goals and find career success.

In Angie's own words she tells what receiving a scholarship from The Greater Kanawha Valley Foundation has meant to her.

"As a young newlywed in the fall of 1990 I was awarded a Capito Fund for Nursing scholarship through The Greater Kanawha Valley Foundation to help me pursue my dream of becoming a registered nurse at the University of Charleston. I was awarded the scholarship for three years until I graduated magna cum laude with a Bachelor's of Science in Nursing in May of 1993. After graduation, I worked at a local hospital in the trauma ICU before returning to college in the fall of 1994 to pursue a Master's Degree in Nursing as a Family Nurse practitioner at Marshall University. When I graduated in May of 1997, I became employed at WV Health Right, a free clinic in Charleston, providing care for the uninsured and underinsured of West Virginia.

I have remained with WV Health Right for the majority of my career and over the past 17 ½ years have cared for literally thousands of needy West Virginians. In the fall of 2013, I again returned to school in pursuit of a Doctorate of Nursing Practice (DNP) at the University of Alabama where I was awarded a full scholarship. This past summer I graduated with a 4.0 from the DNP program and fulfilled my life-long dream of earning a terminal degree in the nursing profession. On July 1, 2014, I became the CEO/Executive Director of WV Health Right, Inc., and am now honored to serve as the leader of an organization that is so vital and important to the most at-risk citizens of our community.

In closing, had it not been for the Capito Fund for Nursing Scholarship and The Greater Kanawha Valley Foundation, I would not be professionally where I am today. This scholarship gave me the opportunity to pursue my academic endeavors and help lay the groundwork for all of my academic and career successes that came thereafter. I will be eternally grateful that I was granted this scholarship and am so happy that I have been able to give back by caring for the neediest people of West Virginia.

Where did our scholarship recipients reside?

Table 3 shows that almost one-third of scholarship recipients between 2010 and 2015 resided in Kanawha County.

It should be noted that 26 percent of scholarship funds are only for Kanawha County residents and 33 percent only include the county.

What institutions did scholarship recipients attend?

Between 2010 and 2015, scholarship recipients attended 135 public and private colleges and universities, and community and technical schools all across the country.

Thirty-five percent of scholarship recipients attended West Virginia University, the institution of choice for the largest fraction of recipients. Marshall University was second with 20 percent.

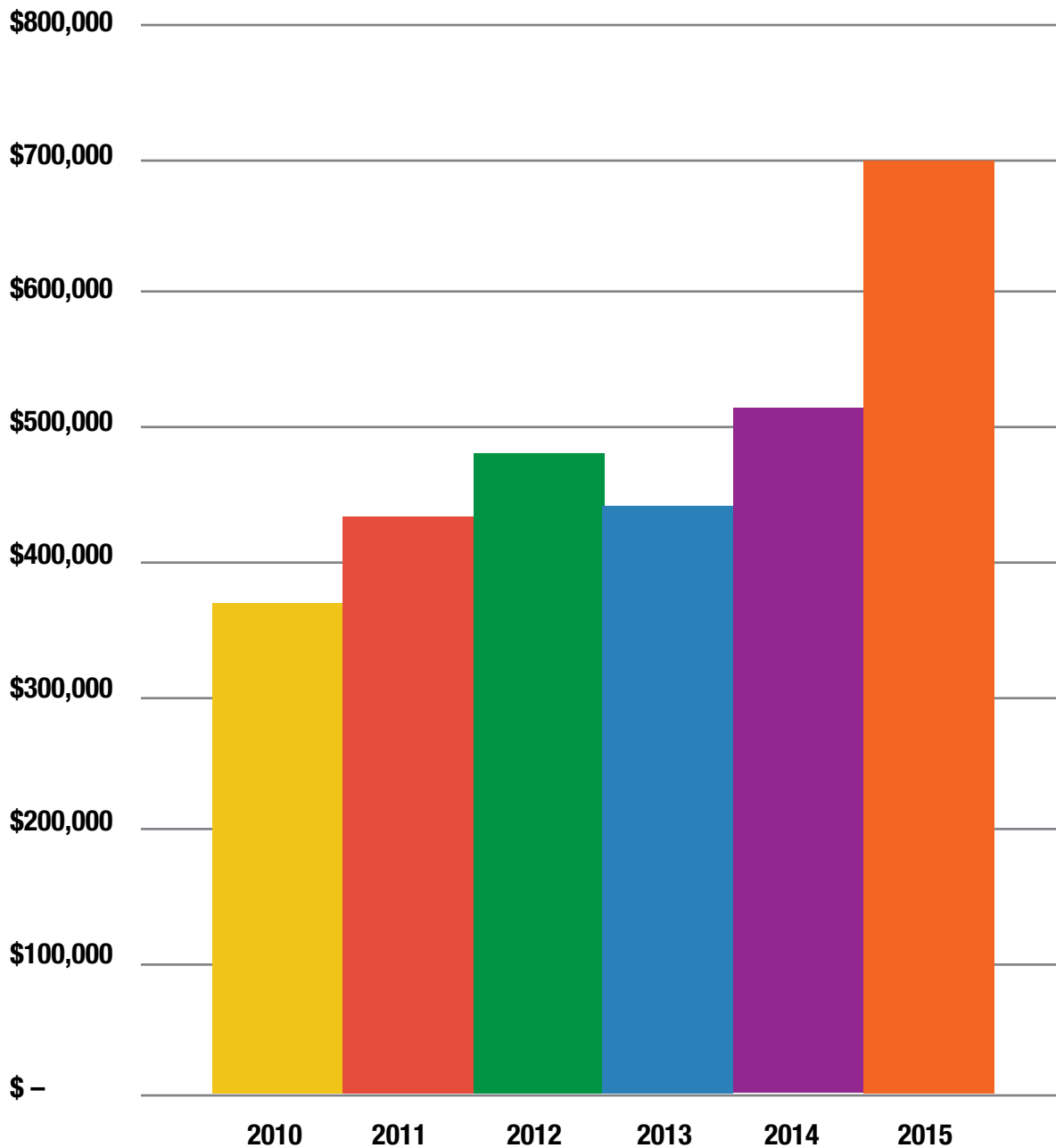




How much did we invest?

The Foundation invested \$2,948,970 in scholarships between 2010 and 2015. The trend is shown in Figure 2. The average amount awarded annually during the period was \$491,495. Some of the variance in the annual rewards were as a result of funds available.

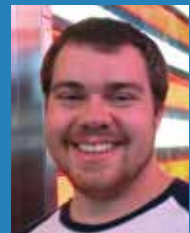
